Information on admission to the doctoral study program Economics and Management accredited in English in full-time and part-time form of study in the academic year 2022/2023

Information shall be submitted in accordance with Regulation No. 343/2002 Coll., on the procedure and conditions of announcement during the admission procedure at universities, as amended.

§ 1 Information on entrance examinations

One applicant has submitted an application for the doctoral study program Economics and Management accredited in English.

The invitation to the entrance examination: June 7, 2022

The entrance examination to the doctoral study program Economics and Management, the field of study Business Economics and Management: June 15, 2022

The entrance examination was oral and took place in front of the entrance committee online.

- When being examined, the candidate demonstrated the expert knowledge of economic theory, mathematical-statistical methods and the selected field in the extent corresponding to the Master's degree curriculum. Part of the entrance examination was professional discussion on the topic of the dissertation based on the propositions that the candidate has stated in his/her application to study.
- In the language examination the candidate proved her conversational knowledge of English and the knowledge of English terminology in relation to the topic of the thesis. The examination involved reading a professional text, and discussion on the topic of the thesis in English.

The Admission Committee shall assess the results of the entrance examination by the points, it is necessary to reach a minimum of 51% of the available points to pass the entrance examination successfully.
