Information on the admission procedure to the follow-up Master's Degree Study Program both in the full-time and part-time form of study in the academic year 2024/2025

Information shall be submitted in accordance with Regulation No. 343/2002 Coll., on the procedure and conditions of announcement during the admission procedure at universities, as amended.

§ 1 Information on entrance examinations

a) the fully entry of test questions or examples that are part of the entrance examination or its part, and for questions with the selection of the correct answer

The entrance examination of the cited academic year at the Silesian University in Opava, School of Business Administration in Karviná (hereinafter referred to as the SU OPF in Karviná) was in the online form and in oral form (interview) in English. The exam consists of two main parts: entrance exam test and online interview. Only applicants who were successful in the online test received an invitation for an interview. Its content involved the validation of applicants' knowledge through the learning potential test. The learning potential test consisted of three parts: microeconomics, macroeconomics, mathematics and statistics. For each part 32 questions were prepared, out of which 8 were chosen by the random number generator for the knowledge test. Each student was given a unique variant of the test.

b) criteria for the evaluation and procedure through which the result of the entrance examination was set or its part, including the procedure leading to the drawing up of the ranking of applicants according to the results of the entrance examination (§ 49, Art. 1 of the Higher Education Act),

The aptitude test was completed online in the IS SU and subsequently software evaluated by the responsible staff of the Institute of Information Technology. In the English language test at level B2 - Upper-Intermediate, a total of 100 points could be obtained. In the aptitude test consisting of microeconomics, macroeconomics and mathematics and statistics, it was possible to gain 240 points in total, each part of the test was evaluated by 80 points. Candidates registered for study were ranked according to the number of points achieved. The online interview was conducted in front of the admissions committee via MS Teams. During the exam, the candidate demonstrated the necessary knowledge in the scope of the written part of the exam as mentioned above. The admission committee

scored the results of the interview. A minimum of 60 points out of a maximum of 100 points was required to pass the interview. Subsequently, the dean of the faculty decided on admission or non-admission to study in accordance with the conditions of the admission procedure.
