Schedule of Educational Activities for the Academic Year 2019/2020

Art. 1 Introductory provisions

In connection with Section 6, Paragraph 3 of Act No. 188/2020 Coll., On Special Rules for Education and Decision-Making at Higher Education Institutions in 2020 and on the Assessment of the Period of Study for the Purposes of Other Acts, as amended, and the 1st Change and Supplement of the Rector's Decision No. 5/2019 on setting the schedule for the 2019/2020 academic year at the Silesian University in Opava I am changing the schedule for the 2019/2020 academic year so that:

- the examination period proceeding after the teaching period in the summer semester is extended to 5. 7. 2020;
- the period of holidays in the summer semester is shortened and will proceed from 6. 7. 2020 to 2. 8. 2020;
- the examination period proceeding after the holiday period in the summer semester is being extended and will run from 3. 8. 2020 to 31. 8. 2020;
- registration for the state final examinations in the IS SU is possible only after passing the last examination/credit, the conditions for registration are specified in the document: "*Conditions of the implementation of the state final examinations of the Silesian University in Opava, School of Business Administration in Karviná in the academic year 2019/2020*";
- the 2nd date of the state final examinations is extended by 5 days, i.e. from 17. 8. to 31. 8. 2020;
- graduation ceremony of graduates from the 1st term of the state final examinations is postponed till autumn: 1. 10. – 9. 10. 2020.
