Article 1

Introductory provisions

In accordance with Article 3(5) of the Study and Examination Regulations for Students of Bachelor's and Master's Degree Programmes of the Silesian University in Opava, as amended (hereinafter referred to as the "the Study and Examination Regulations"), this Rector's Decision establishes the timetable for the academic year 2023/2024.

Article 2

Timetable for the academic year 2023/2024

- 1) The timetable for the academic year 2023/2024 establishes the dates of events according to Articles 3 (1) to (4) of the Study and Examination Regulations as follows:

Start of the academic year	1 Sep 2023
Winter semester	
Teaching period (13 weeks)	25 Sep 2023 – 23 Dec 2023
Winter break	24 Dec 2023 – 1 Jan 2024
Examination period	2 Jan 2024 – 18 Feb 2024

Summer semester	
Teaching period (13 weeks)	19 Feb 2024 – 19 May 2024
Examination period	20 May 2024 – 30 June 2024
Summer break (courses related to study programmes and professional practise can take place in this period, providing that students get a minimum of four weeks of uninterrupted free time)	1 July 2024 – 4 Aug 2024
Examination period	5 Aug 2024 – 31 Aug 2024
Exam completion deadline	31 Aug 2024
End of the academic year	31 Aug 2024

- 2) In addition to the specified periods in this timetable, there may be instances where there are classes for study programmes in a foreign language, combined study formats, state final examinations, and other events during the academic year that are not covered in Article 3 (1) to (4) of the Study and Examination Regulations. These additional periods can be determined by the dean of the faculty.
- 3) In cases where a study programme is jointly conducted by a university and a higher education institute, the director of the respective higher education institute assumes the role of the dean.

Article 3

Final provisions

This Decision shall enter into force on the date of issue and take effect on 1 September 2023.
