II. Amendment to the Election Rules of the Academic Senate of the Silesian University in Opava dated ... 2022

Article 1

The Election Rules of the Academic Senate of the Silesian University in Opava are amended as follows:

1. In Article 10, paragraph 4), the wording of the first sentence is amended as follows:
"4) A member of the Senate who was elected as a student and has duly completed a bachelor's degree programme and enrolled in a follow-up master's degree programme at the same faculty, or has duly completed a master's degree programme and enrolled in a doctoral degree programme at the same faculty, shall notify the Chair of the Senate in writing within 7 days of the date of successful completion of their studies that they intend to become a substitute member."
2. A new paragraph 5) is inserted into Article 10, which reads as follows: "If the candidate does not notify the Senate within the time limit specified in paragraph 4 that they intend to become a substitute, their membership in the Senate shall expire and they shall not become a substitute."
3. In Article 10, the existing paragraphs 5) to 9) shall be renumbered as paragraphs 6) to 10).

Article 2

Final provisions

- 1) This amendment to the Election Rules of the Academic Senate of the Silesian University in Opava of 25 August 2017 was approved in accordance with Section 9(1)(b)(3) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Supplements to Other Acts (the Higher Education Act), as amended, by the Academic Senate of the Silesian University in Opava on 11 January 2022.

- 2) This amendment shall enter into force pursuant to Section 36(4) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Supplements to Other Acts (Higher Education Act), as amended, on the date of its registration by the Ministry of Education, Youth and Sports.
- 3) This amendment shall take effect on the date of its entry into force.
