# **Rector's Decision No. 14/2024**

## **Announcement of the Rector's Scholarship Programme**

### **to support active involvement of students in cooperation with Business Gate Academy at the Silesian University in Opava**

#### **Article 1**

##### **Introductory provisions**

This Decision announces the Rector's Scholarship Programme to support active involvement of students in cooperation with the Business Gate Academy (hereinafter referred to as "BGA") at the Opava units of the Silesian University in Opava (hereinafter referred to as "the University") in the academic year 2024/2025 and sets out the conditions for awarding an extraordinary scholarship pursuant to Article 7(1)(c) of the University Scholarship Regulations (hereinafter referred to as "the Scholarship Regulations"), as amended.

#### **Article 2**

##### **Definition of the range of students and conditions for awarding the scholarship**

- 1) An extraordinary scholarship to support students actively involved in cooperation with the BGA at the Opava units of the University in the academic year 2024/2025 will be awarded to students who, beyond their study obligations, act as an operator or administrator within the BGA.

- 2) The BGA Operator and Administrator positions referred to in paragraph 1 will be filled on the basis of the results of a competitive selection process involving the Programme Coordinator and the Course Supervisors.
- 3) Students in an operator or administrator position within the BGA must develop and defend a team project in the 2024/2025 academic year.
- 4) The scholarship is awarded without a student's application, the basis is the payroll of the students concerned, confirmed by the programme coordinator and sent in writing, or delivered in person, to the Department for Student Affairs of the Rector's Office (Olbrichova 625/25, 746 01 Opava) or by e-mail to [prorektor-ped@slu.cz](mailto:prorektor-ped@slu.cz) by the end of February for the period September 2024 to February 2025 and by the end of June for the period March to June 2025.
- 5) The agenda related to the registration of scholarships is maintained by the authorized employee of the Department for Student and Social Affairs of the Rector's Office.

### **Article 3**

#### **Amount of scholarship**

- 1) The scholarship will be awarded at the level of the position:
  - a) 10.000 CZK one-time for serving as an operator leading a student team within the BGA;
  - b) CZK 7,000 per month in the period September 2024 to February 2025, or March to June 2025 for the position of administrator involved in the organisation of the BGA's activities.
- 2) The amount of the scholarship under paragraph 1(b) shall take into account each month in which the student has served as an administrator, the scholarship shall not be reduced and shall remain at the full amount.

### **Article 4**

#### **Payment of the scholarship**

- 1) Each student who meets the eligibility requirements will be paid the exceptional scholarship by the end of March or the end of July 2025.
- 2) The scholarship is paid in accordance with the Scholarship Regulations after the legal validity of the decision to award the scholarship, in cashless form to the student's bank account listed in the IS - if the student does not have valid bank account details filled in the IS, the scholarship will not be paid.
- 3) In the event that the decision on the award of the scholarship is not final by the date referred to in paragraph 1, the scholarship will be paid individually according to the date the decision becomes final.

### **Article 5**

#### **Common provisions**

- 1) Reduction and withdrawal of the scholarship is regulated in Article 18 of the Scholarship Regulations.
- 2) Decisions are delivered via the IS SU.

**Final provisions**

This Decision shall enter into force and effect on the date of its publication.
