I. Amendment of the Rules of Habilitation Procedure and Procedure for Appointment as Professor at Silesian University in Opava dated 8 August 2017

Article 1

The Rules of Habilitation Procedure and Procedure for Appointment as Professor at Silesian University in Opava dated 8 August 2017 are amended as follows:

1. In Article 19, paragraph 4) is deleted and replaced with a new paragraph 4), which reads as follows:
"4) The publication of habilitation theses pursuant to Section 75(4) of the Act shall be carried out by the faculty without undue delay by uploading an electronic version of the habilitation thesis to the university's information system archive (the "Publications/Repository" module), where it shall set access rights to the document so that it is publicly available."

Article 2

Final provisions

- 1) This amendment to the Rules of Habilitation Procedure and Procedure for Appointment as Professor at the Silesian University in Opava of 8 August 2017 was approved pursuant to Section

9(1)(b)(3) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Supplements to Other Acts (the Higher Education Act), as amended, by the Academic Senate of Silesian University in Opava on 12 May 2020.

- 2) This amendment shall enter into force pursuant to Section 36(4) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Supplements to Other Acts (Higher Education Act), as amended, on the date of its registration by the Ministry of Education, Youth and Sports.
- 3) This amendment shall take effect on the date of its entry into force.
