Rector's Decision No. 3/2025 on setting the timetable for the academic year 2025/2026 at the Silesian University in Opava

Article 1 Introductory provisions

In accordance with Article 3(5) of the Study and Examination Regulations for Students of Bachelor's and Master's Degree Programmes of the Silesian University in Opava, as amended, (hereinafter referred to as the "Study and Examination Regulations"), this Rector's Decision sets out the timetable for the academic year 2025/2026.

Article 2 Schedule for the academic year 2025/2026

1) The timetable for the academic year 2025/2026 sets out the dates of the events referred to in Article 3(1) to (4) of the Study and Examination Regulations as follows:

- 2) Outside of the periods specified in this schedule, periods of instruction in a study programme in a foreign language, in a combined form of study, state final examinations and other dates during the academic year not specified in Article 3(1) to (4) of the Study and Examination Regulations may be set by decision of the Dean.
- 3) In the event that a study programme is implemented by a university together with a higher education institute, the director of the relevant higher education institute exercises the powers of the dean.

Article 3 Final provisions

This Decision shall enter into force on the date of its publication and shall take effect on 1 September 2025.
